Interim ED Report: Kimberly Rusnak

- Transition to independence from The Community Foundation of Greater Washington: arrival of 501(c)(3)letter of determination, interviewing of HR firms, getting O&D insurance quotes, receiving DHHS written approval to spend \$280K, waiting for MCPS funding, waiting for remainder of \$425 from COF grants
- 2. Start of actual COA work: Consultant Laura Jahromi is doing landscape analysis, collaboration happening with Children's Funding Project, joint convening happening with Montgomery Moving Forward and NonProfit Montgomery
- 3. Accomplishment of COF commitments: Ralph Morales is managing COF grants, Kimberly Rusnak is managing 2nd year of MSDE grant at Rolling Terrace Elementary and Strathmore Elementary

COF/COA discussion

Discussion ensued about the ambiguity of the COF/COA relationship. Myrna Peralta wanted to go on record saying that it's important that COA is not just COF buried under a new name and a new legal status – if that is the case it has implications for the scope of work and accountability; there is a need for greater clarification on the relationship. Chair Kevin Beverly tabled the discussion till January board meeting.

Motion to approve COA working budget

A motion to approve the working budget as presented by Chair was made by Hannah Hahn. The motion carried by unanimous vote of 15 board members present.
